US Domestic Ground Shipments of less than 150 lbs

All small package shipments of 150 lbs or less and consisting of less than seventeen (17) cartons should be shipped via FedEx Ground and billed to Littelfuse account # 356580672. Do not insure the shipments unless instructed by Littelfuse.

• US Domestic air shipments of less than 150 lbs

All shipments that require an expedited service or premium shipment should be shipped via FedEx Express using Littelfuse account # 356580672 and must be notified to Littelfuse prior to shipping for approval. All shipments sent without Littelfuse approval will be billed back to the shipper.

• International shipments less than 150 lbs

All small international package shipment of 150 lbs or less should be shipped via DHL Express using Littelfuse Import account # 963186029.

• International shipments over 150 lbs

Please contact your respective Sourcing Manager for the assigned Freight Forwarders of the specific shipping location. Littelfuse must be notified before shipping. Pre-alerts containing the HAWB and customs documentation (packing list, commercial invoice and SLI) are required and should be emailed to below contacts:
